

SUMMARY ANNUAL REPORT FOR ROCHESTER COLLEGE RETIREMENT BENEFITS PLAN

This is a summary of the annual report for the ROCHESTER COLLEGE RETIREMENT BENEFITS PLAN (Employer Identification Number 38-1619831, Plan Number 001) for the plan year 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$531,667. These expenses included \$484 in administrative expenses and \$531,183 in benefits paid to participants and beneficiaries, \$0 in certain deemed and/or corrective distributions, and \$0 in other expenses. A total of 301 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$3,803,986 as of the end of the plan year, compared to \$4,406,170 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$602,184. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of -\$70,517, including employer contributions of \$0, employee contributions of \$176,023, other contributions/other income of \$0, and earnings from investments of -\$246,540.

1. An accountant's report.
2. Financial information and information on payments to service providers.
3. Assets held for investment.
4. Insurance information, including sales commissions paid by insurance carriers.
5. Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
